MANAGING DIRECTOR REPORT

Human Resource Director, Ms. Donna Poplar congratulated Finance Director, Ms. Coetta Adams on her upcoming retirement after 26 years of service. Ms. Poplar stated that Dianna Robertson would be Interim Finance Director until a final candidate is chosen for the position.

<u>Finance Director Salary</u> - Commissioner Dickerson asked about the advertised salary for the posted position of Finance Director and inquired why it is so much lower than the current salary range for that position. Commissioner Kautman-Jones stated that it is easier to go up in salary than to go down. Ms. Poplar indicated that it will be difficult to attract a qualified candidate when the salary is lowered.

<u>Financial Statements</u> – Finance Director Adams stated that she provided the Board with a copy of the quarterly financial statements through March 31, 2019.

ACT 51 Overpayment – Finance Director, Coetta Adams informed the Board that ACT 51 over estimated their payments to road agencies last year and will be deducting this overpayment from their distributed 2019 MTF fund payments. Ms. Adams stated that she would be meeting with the auditors from Plante Moran to discuss the overpayment. This may result in a budget adjustment needing to be made in the future. Ms. Adams said that she had anticipated this overpayment being taken back so it will not have much effect on the Road Commission budget.

COMMISSIONERS CONCERNS

<u>Security Precautions and Safeguards for Cyber Security</u> - Commissioner Kautman-Jones thanked Network Administrator, Mr. Mike Lewis for information included in the Board packet regarding the security and safeguards in place at the Road Commission concerning ransomware attacks.

<u>Hot Mix Asphalt plants</u> - Chairperson Mandelaris inquired if the hot mix asphalt plants are open yet and staff replied that the Holly plant is open but the Flint plant opening would be delayed. Chairperson Mandelaris stated he had a pothole complaint from a resident he will pass on to the Maintenance department.
