#### **PUBLIC HEARING**

At 10:04 a.m. Traffic Engineering Manager, Ms. Bonnie Wood opened the public hearing regarding the consideration of the abandonment of a portion of Triple-Oak Drive, located off Fenton Road, Supervisor's plat of Homesites, Liber 17, Page 36, Fenton Township.

The Road Commission was petitioned by seven freeholders or more to abandon this portion of roadway. Ms. Wood stated that notices of the proposed abandonment were mailed to each owner and freeholder with interest in this action and they were posted in the area and at the township hall. At this time, Ms. Wood asked if there are any objections to this action. Three residents from Triple Oak Drive attended the public hearing, Ms. Courtney Clauson, Ms. Heather Lueckemann-Ade and Mr. Michael Ade.

Ms. Courtney (Gregory) Clauson, 1526 Triple-Oak Drive voiced her objections regarding the abandonment of Triple-Oak Drive citing difficulties when pulling out of their driveway and as well as when visitors to their home try to pull out of their driveway. She stated her garbage receptacles must be placed down the street for garbage pick-up. Commissioner Lane asked to review Ms. Clausen's photos that she had brought with her.

Ms. Wood commented that Triple-Oak Drive is a very old plat from the early 1900's and we only have 20 feet of right a way on this gravel road. Ms. Wood checked with the district supervisor and he stated that the GCRC does not maintain this drive to the end because it backs up to driveways.

Ms. Heather Lueckemann-Ade, 1527 Triple Oak Drive stated that she and her husband were in favor of the abandonment of Triple Oak Drive. She explained that the front of her home is very close to the road and vehicles back up into her front yard and the abandonment would help alleviate this issue.

Commissioner Lane asked for the width of this easement and staff answered it is 24 feet. Commissioner Lane stated that this would be split between the two landowners, 12 feet on each side.

Vice Chairperson Mandelaris asked if this proposed abandonment has gone before the Township Board and did seven property owners sign this petition. Ms. Wood stated that yes, seven property owners signed the petition and she sent the township a letter but she does not have any official correspondence from them.

Commissioner Lane asked if this abandonment is approved, who will be updating the legal description for both of their properties and would there be anybody to insure them where the property line is to be. Staff stated as a property owner, they would be responsible to get their own survey.

Vice Chairperson Mandelaris stated that the resolution would have to be amended because there is an objection to the proposed abandonment. Vice Chairperson Mandelaris asked Ms. Lueckemann-Ade what they would do with their half of the property if this abandonment were granted. Ms. Lueckemann-Ade commented that she just wants the area defined on where the road and her property lines lie.

At 10:32 a.m., Ms. Wood closed the public hearing and recommended the Board take this under advisement and not take action on the resolution at this time. Commissioner Elkins agreed with Vice Chairperson Mandelaris that we should get documentation from Fenton Township before we take any action on the resolution.

## MANAGING DIRECTOR REPORT

If the board members would be willing to donate for a gift card, she would be very appreciative. Vice Chairperson Mandelaris and Commissioner Elkins agreed that this is a very good idea.

<u>Lighted Traffic Signs</u> - Commissioner Elkins noticed that there are a lot more of the lighted traffic signs showing up in the county, which he feels is a great idea. They force you to look at the signage and make a nice addition to the road system.

<u>2021 County Road Association Commissioner's Seminar</u> - Vice Chairperson Mandelaris commented that our Managing Director would be giving the welcoming speech at the 2021 County Road Association Commissioner's Seminar in October. He would like to encourage the entire board to attend this seminar to support our Managing Director.

<u>Table of Organization</u> - Vice Chairperson Mandelaris noticed we increased the number of employees in the table of organization by 10. Staff stated that the number is actually 11 employees and will be updated to reflect this.
