MANAGING DIRECTOR REPORT

<u>County Road Association Highway Conference</u> - Managing Director Peivandi reminded the Board that the County Road Association Annual Highway Conference would be held on March 08, 2022 through March 10, 2022 at the Radisson in Lansing. Please let him know if they would like to attend. Chairperson Mandelaris stated he would be attending one day of the conference but would not need a hotel room.

Surcharge for 2023 Western Star (Daimler) Truck Purchase — Operations Director Randy Dellaposta stated that the Road Commission just received notification of a surcharge for the seven (7) 2023 Western Star (Daimler) Trucks that were ordered. Mr. Dellaposta said that Daimler Truck is passing along the surcharge where in the past the dealers were able to absorb these charges, but they are not able to do this any longer due to the cost. Daimler Truck is passing a pricing surcharge of \$4,200 per truck, in addition to the \$300 MY23 product cost surcharge announced earlier this year to cover the increase in commodity and supply chain related costs. This surcharge totals \$31,500. Daimler is allowing the customers to pull their orders, but he does not recommend that we do this due to a truck shortage. Mr. Dellaposta will be presenting this increase to the Board at the January 04, 2022 meeting but he would like the Board to approve this increase in order to proceed with this purchase.

Covid Update – Mr. Dellaposta presented the current Covid report to the Board as prepared by Ms. Monica Pearson, Human Resource Department. Mr. Dellaposta stated that there are five employees currently out quarantining with Covid. From March of 2020 to the present time, we have had 96 employees that were affected by this virus, 27 of those employees were infected and one employee is still out on long-term leave due to the virus. Mr. Dellaposta added that we have asked the Human Resource Department to prepare a line chart showing the peaks and valleys (from March 2020 to the present) regarding Covid and those employees affected by it. In addition, Mr. Dellaposta added that there are federal mandates being considered for employers of 100 or more employees. Information is coming through via MCRCSIP and staff will keep the Board informed of any changes necessary. Human Resource Director, Donna Poplar added that we could share with the board the number of employees that have been vaccinated but we cannot share the names of those vaccinated.

<u>First Snowfall</u> - Commissioner Lane stated that the county had their first salting of her roads in Grand Blanc Township and she was very happy with the results. Ms. Lane wished everyone a happy and healthy holiday and asked about the employee that was injured in the tractor accident and whether he is back to work. Staff stated that he is doing much better but is not back to work yet.

Commissioner Elkins and Chairperson Dickerson wished everyone a safe and happy holiday.

<u>Board Minute Books</u> - Vice Chairperson Mandelaris stated that he was given a copy of the Secretary's board minute books for 2014 and would like staff to continue publishing the minutes in a book format. Secondly, Vice Chairperson Mandelaris stated that the Board meeting this morning is not typical of our regular board meetings, usually they run very smoothly.
