MANAGING DIRECTOR REPORT

<u>Title VI Non-Discrimatory Plan</u> - Human Resources Director, Donna Poplar stated as a part of the GCRC being compliant with the U.S. Department of Transportation, staff has put together the yearly Title VI Non-Discrimatory Plan for insertion on the GCRC website. The Plan will require the signature of the Chairperson.

COMMISSIONERS' CONCERNS

<u>Dust Complaints</u> – Vice Chairperson Kautman-Jones said she has received dust complaints on the gravel roads in Atlas Township. Ms. Kautman-Jones said due to the dry weather, the residents are requesting that more applications of calcium chloride or brining in between the calcium chloride applications be applied if possible.

<u>Managing Director Annual Evaluation</u> – Commissioner Mandelaris said the Board would like to discuss changing the Managing Director's Annual Evaluation from a two-year review to an annual one-year review before the end of this year. Commissioner Mandelaris stated that he agrees to this change and Vice Chairperson Kautman-Jones said she strongly supports a yearly review. It is the consensus of the Board members present to change the review to a yearly review.

Vice Chairperson Kautman-Jones said the Board members will use the evaluation form they have used in the past and the evaluations should be completed and turned into the Chairperson and Vice Chairperson by September 14, 2020. The annual evaluation will be completed by the October 20, 2020 Board Meeting.

<u>Conference Call Board Meeting</u> - Commissioner Mandelaris commented that he called into the Board meeting on June 16, 2020 using the call in number and noticed he was charged for 107 minutes of long distance charges on his phone, which he will be submitting for reimbursement.

<u>Great Lakes National Cemetery and Holly Road</u> – Commissioner Arceo stated that he was at the Great Lakes National Cemetery two weeks ago, and said he was surprised at the amount of traffic and congestion on Holly Road leading to the cemetery, partly due to the Road Commission of Oakland County's ongoing construction project on Holly Road. Commissioner Johnson stated that funeral services are scheduled every 20 minutes at Great Lakes National Cemetery, which contributes to the traffic and congestion.
