MANAGING DIRECTOR REPORT

<u>Update on COVID-19 Procedures</u> – Human Resource Director Donna Poplar updated the Board on the current safeguards in place at the GCRC regarding COVID-19. Starting this week, Ms. Poplar stated that the GCRC is taking the temperatures of all employees every morning when they enter the facilities as well as requiring employees to fill out a daily electronic health-screening form upon arriving at work. This makes the GCRC 100% compliant with MIOSHA requirements regarding the COVID-19 procedures. Ms. Poplar commended the department directors as well as the maintenance supervisors for their efforts in combating the spread of COVID-19 and keeping their employees informed and safe in the workplace.

<u>Federal Safety Projects Awarded to GCRC</u> – Mr. Eric Johnston, Engineering Director stated that the following projects that were submitted to MDOT for Federal Safety Funding have been accepted:

- Lake Road at Webster Road Solar Beacon Signs
- Lapeer Road at Gale Road to 2200' east
- Seymour Road to curve 1500 'N of Farrand Road
- Various Intersections (Irish @ Coldwater; Irish @ Mt. Morris and; Linden @ Dodge) Solar Beacon installation (4 way stop HSIP Systemic)

In addition, Mr. Johnston stated, two bridge projects were also approved for Federal Safety Funding:

- Hogan Road over the Shiawassee River
- Torrey Road over the Swartz Creek

Redistricting the District Garages – Operations Director Randy Dellaposta stated that Mr. Branch, Mr. Peivandi and himself are developing the final numbers and determining lane miles to form the Metro District (Genesee Township and Mt. Morris Township). Staff should have something in place for the Board by the November 17, 2020 Board Meeting. Mr. Dellaposta stated that the positions will have to be posted per the union contract but tentatively we are looking at eight employees for this district.

COMMISSIONERS' CONCERNS

<u>GCRC Board Member Handbook</u> – Vice Chairperson Kautman-Jones stated that she is still working on the Board member handbook.

<u>County Road Maps</u> – Commissioner Mandelaris asked staff if there are any plans to update the county map we currently have. Managing Director Fred Peivandi commented that the GCRC still has quite a few maps in stock but with the Dort Highway project starting we may update the maps once that project is finalized. Mr. Peivandi said when we have the new county map printed, we would probably order a smaller quantity than we have done in the past.

<u>Plastic Barriers in Fleet Vehicles</u> – Vice Chairperson Kautman-Jones commented that she was able to separate drivers in her personal business vehicles by placing plastic dividers between the two employees in a truck. She suggested that GCRC might want to implement something similar when two people need to share a fleet vehicle. Staff thanked her for her suggestion.

<u>Atlas Township Supervisor Election</u> - Chairperson Dickerson wished Vice Chairperson Kautman-Jones good luck in the election today for the Atlas Township Supervisor position.
