MANAGING DIRECTOR REPORT

<u>COVID-19 Update</u> – Human Resource Director Ms. Donna Poplar updated the Board on the current COVID-19 cases at the GCRC. Currently we have had 16 employees testing positive with the virus. Of those 16, only one employee is out on extended leave (6 months) due to the virus. Ms. Poplar stated that 70 out of 151 of our employees have been affected by COVID-19, either testing positive or having to quarantine due to contact with someone that did test positive. In addition, the Covid worksheet that employees fill out every morning will include vaccination questions on Monday, May 10, 2021. Ms. Poplar said that these questions are strictly volunteer and will be kept confidential.

Chairperson Dickerson stated that the Board extends their heartfelt wishes for a full recovery to the GCRC employee that is still out on COVID-19 related leave.

<u>President of the County Road Association of Michigan (CRA)</u> – Managing Director Fred Peivandi stated that he was elected president of the County Road Association of Michigan on April 01, 2021. Mr. Peivandi remarked that he has been very busy with CRA and will be attending a workshop this Thursday and Friday in Gaylord, Michigan. In addition, he said he would be attending the Human Resource and Finance CRA Conference in Sault Ste. Marie on May 18, 2021, along with Finance Director Tracy Khan and Finance Manager Brenda Kleinfeld.

<u>Professional Traffic Operations Engineer (PTOE) Certification</u> – Engineering Director, Mr. Eric Johnston congratulated Ms. Bonnie Wood, Traffic Engineering Manager on obtaining her PTOE Certification, which is a certification designating her as a Professional Traffic Operations Engineer. The certification demonstrates her knowledge, skill and ability in the specialized application of traffic operations engineering. The Board and staff members joined Mr. Johnston in congratulating Ms. Wood on her achievement.

COMMISSIONERS' CONCERNS

Chairperson Dickerson congratulated Fred Peivandi on being elected president of County Road Association of Michigan for the 2021-2022 year as well as Bonnie Wood for her Professional Traffic Operations Engineer certification.

Chairperson Dickerson said he was approached by the UAW President regarding outsourcing practices at the Road Commission. He would like to have a meeting with Human Resources and staff regarding these practices.

Commissioner Lane stated that the Board adopted the Code of Conduct in January and she stated she would like the board members to consider adopting a Best Practices Policy at a future meeting.

Ms. Lane thanked Maintenance Director Anthony Branch for providing her with maps of the district garages. Ms. Lane said she and Commissioner Elkins have had the opportunity to visit the districts and stated there is a wonderful group of people that work at them. Ms. Lane also

commented that she had difficulty maneuvering the turn onto Morrish Road to go to the Swartz Creek garage once she got off the trunkline. Vice Chairperson Mandelaris agreed that this area is very congested. Mr. Peivandi commented that the Road Commission has looked into an alternative entrance to the Swartz Creek district garage but was unable to obtain an easement from the city of Swartz Creek. Staff stated they would look into this area again to see if they could make some changes. Commissioner Arceo agreed that this is a busy area and stated that the traffic might be more congested if they have the racetrack operating again.

Commissioner Elkins also said he enjoyed visiting the Swartz Creek garage and meeting the employees that work in this district.

Vice Chairperson Mandelaris thanked staff for providing the colored maps in the board packets, especially with the consent items.
