<u>Letter Correspondence from Police Chief Matthew Bade, re: Elms Road at Hill Road</u> – In correspondence dated June 04, 2021, Police Chief Matthew Bade, Metro Police Authority of Genesee County, expressed concern regarding traffic safety at the Elms Road at Hill Road roundabout and requested replacing the rocks in the interior. <u>Letter Correspondence to Police Chief Matthew Bade, re: Elms Road at Hill Road</u> – In correspondence dated June 22, 2021, Managing Director, Fred Peivandi, committed to proceed with the removal of the rocks and the paving of the center island of the roundabout at Elms Road at Hill Road. Commissioner Mandelaris asked for a status report on the stones. Managing Director Peivandi said that a job number has been authorized and the work is expected to be done in July or August. Managing Director Peivandi has received a call from Police Chief Bade thanking

GCRC for removing the stones. Commissioner Lane asked how much the work will cost. Managing Director Peivandi replied that the 2017 estimate was \$26,000 but since it is now being handled through the Engineering and Maintenance Departments, the cost should be lower.

#### **DISCUSSION**

MDOT Contract No. 21-5239, Dort Highway Extension Pathway, GCRC No. 67-W50774, Grand Blanc Township – In a memorandum dated June 22, 2021, staff requested Board approval

for MDOT Contract No. 21-5239 for the construction of the Dort Highway Extension Pathway from Baldwin Road to Cook Road in Grand Blanc Township. Estimated project funding participation is as follows:

Referring to Incoming Correspondence Item A-1, Mr. Arceo expressed safety concerns at other intersections such as Dye Road at Court Street in Flint Township. Mr. Arceo would like a letter sent to each of our Representatives in Lansing, with a copy to MDOT, requesting more funding for roundabouts for added safety. The answer to Police Chief Bade by the Managing Director is a plus.

Mr. Mandelaris added that the reason that GCRC was considering a roundabout at Dye Road and Court Street was a fatality. Mr. Mandelaris inquired as to why electronic signatures on these contracts are required. Mr. Johnston answered that it is an MDOT requirement. Mr. Mandelaris asked if a roundabout has been considered on Elms Road at Lennon Road. Mr. Johnston replied that GCMPC did a study and has recommended a roundabout at this location, but no funding has been awarded yet. Managing Director Peivandi said that the Dye Road at Court Street location had right-of-way acquisition issues and a lot of opposition, so the project had to be dropped. GCRC did improve the safety of the intersection by installing flashing beacons and lighted stop signs. There may be right-of-way issues on Elms Road at Lennon Road also.

Mr. Elkins asked if the funds are budgeted. Mr. Johnston answered no, as it is not a current project. The application has been submitted to MEDC and we should find out in August if this project has been funded. Grand Blanc Township has the design underway. Construction is scheduled for Spring 2022.

Ms. Lane inquired about the bridge on the map that is not an all-season bridge. Mr. Johnston explained that the project area west of Holly Road is a current project being done next year with State CMAQ funds. The area east of Holly Road was widened to 5 lanes in 2007-2008 when the bridge over Ray Road was constructed. This project will start west of Holly Road and transition from 5 lanes to 2 lanes at the bridge. Bridges are not classified as "all-season". Ms. Lane asked if Grand Blanc Township will be responsible for part of the \$5 million project cost. There is a minimum 20% construction match required. Mr. Johnston said that the Township will pay for half of the match and GCRC will pay half. The P.E. and C.E. are considered a 'soft match', which when combined with the construction match will total a 40% overall project match. The Township has hired Rowe PSC to design the project. GCRC will either hire a consultant or use in-house staff for the construction engineering.

Mr. Arceo asked if GCRC is the eyes and ears for the Township. Mr. Johnston explained that GCRC is the Act 51 agency and all of the funding goes through us.

Ms. Lane asked if the first way of protecting a culvert is a lining. Mr. Johnston said that it depends on the type of culvert, but a lining is expensive. Maintenance can replace culverts which are 48 inches or less. This culvert is deeper and requires full design and permitting. Managing Director Peivandi added that culverts 60 inches or greater are inspected in the winter months and staff has a list of critical culverts to keep an eye on.

Mr. Mandelaris asked if Roads & Bridges Advisory Committee meetings will be held in person now. Managing Director Peivandi answered yes. Mr. Mandelaris asked if the County Board has eliminated the restrictions. Mr. Elkins noted that last week the TAC meeting was in person.
