MANAGING DIRECTOR REPORT

<u>Equipment Operator Training at GCRC</u> - Managing Director Dellaposta commented that the November 16, 2023, GCRC held equipment operator training to assist operators with 5 or less years'

experience at GCRC. The training was also open to those operators with more than 5 years' experience. St. Clair County Road Commission joined the training, sending seven of their operators for the training. Mr. Dellaposta thanked Safety Coordinator, Felicia Ivey, and Communications Coordinator Kylie Dontje for their assistance in setting up the training and getting the press to cover the event. Mr. Dellaposta added that this was outstanding training, and we would like to expand this training next year. Mr. Smith asked if this is the first time we've done this type of training. Mr. Dellaposta said yes.

<u>Salt Delivery Status</u> – Mr. Dellaposta gave an update on the GCRC salt delivery status. We have pre-ordered salt and received \$765,000 of the approximately \$1.5 million allotted salt delivery that was budgeted this year which equals approximately 12,000 tons of salt (\$65.08 per ton). Staff have worked diligently to ensure that our fleet is winter ready as well.

COMMISSIONER'S CONCERNS

<u>Winter Preparedness News Coverage</u> - Mr. Massey asked if the Communications Coordinator, Ms. Kylie Dontje, will be interviewing with the news stations regarding winter weather preparedness. Ms. Dontje answered that they covered winter preparedness during the driver training news coverage but usually the news stations will reach out to us first when snow is predicted. Mr. Dellaposta answered that GCRC will reach out to the news stations for coverage of our winter weather preparedness.
